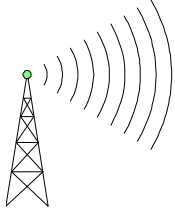

The door prize drawing was held and Bob Smothers, WD5FDU, won a Travel Plus CD for computers, generously donated by Dave Jenkins.

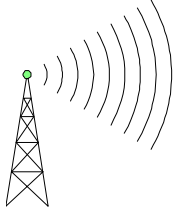

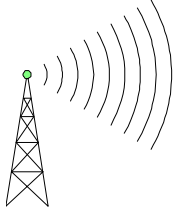

Kathy Croker will send a member listing via email to the Club members.

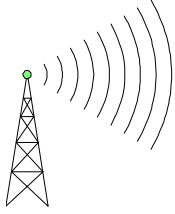

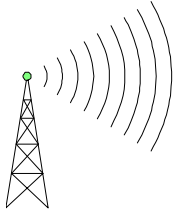

Bob Smothers generously donated to the Club treasury his portion of the test session fees, received during our co-test session wherein he acted as coordinator.

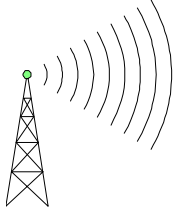
